VISITOR CENTER SERVICES - THE VISITOR CENTER HONORS, RECOGNIZES, AND CELEBRATES AMERICA'S ENDURING MARITIME HERITAGE THROUGH COMMEMORATIVE CEREMONIES, REUNION MEETINGS, REENLISTMENT AND RETIREMENT CEREMONIES, BAND CONCERTS, FILM AND VIDEO PRESENTATIONS, PHOTOGRAPHIC AND DATA COLLECTIONS, SPECIAL EVENTS, AND EXHIBITS.

DUE TO THE GLOBAL COVID-19 PANDEMIC, THE VISITOR CENTER WAS CLOSED TO THE PUBLIC ON MARCH 12, 2020. AS A RESULT OF THE CLOSURE, SEVERAL IN-PERSON EVENTS WERE CANCELLED. THE NAVY MEMORIAL WAS ABLE TO IMMEDIATELY PIVOT TO PRODUCING THE THE VISITOR CENTER EVENTS VIRTUALLY, THEREBY CONTINUING TO FULFILL ITS MISSION IN SPITE OF THE PANDEMIC.
